Hand hygiene signage. Soap, hot water and paper towels provided in toilets. Cleaning of frequently touched surfaces by cleaner. Cleaning products provided throughout the premises for use by users. Hygiene guidance provided to HIRERS. PA system will not be available until further notice. 	
Contact with rubbish infected with COVID-19	Users of the Village Hall Volunteer helpers Management Committee Cleaner Contractors	 Adequate provision of waste bins to prevent uncontained rubbish. Bin liners used in all waste bins. Waste bins emptied regularly by the cleaner Liner removed & replaced with new to avoid contact with waste. 	
5. Contact with COVID-19 by cleaners	Volunteer helpers Management Committee Cleaner	 Disposable gloves to be worn when cleaning. Face masks and aprons to be worn when cleaning after suspected case of COVID-19. Cleaners follow PHE COVID-19: Cleaning in non-healthcare settings guidance where contamination is suspected. Volunteers over 70 or in a vulnerable group will not assist with cleaning. Cleaner advised to change/launder outer clothing after cleaning duties. Caretaker to wear overalls to cover outer clothing.
